AN ORDINANCE PROVIDING FUNDING FOR THE RAIL FREIGHT PROJECT FOR THE CITY OF LINDEN AND APPROPRIATING \$2,558,270 FOR SUCH PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LINDEN, IN THE COUNTY OF UNION AND STATE OF NEW JERSEY, AS FOLLOWS:

Section 1. The City of Linden, in the County of Union, New Jersey, authorizes the Rail Freight Project to be undertaken and to be funded from the sources specified in Section 2 of the Ordinance.

Section 2. The amount of \$2,558,270 is hereby appropriated for the purposes stated in Section 1 of the Ordinance, which sum includes \$2,302,443 expected to be received from the New Jersey Department of Transportation Rail Freight Assistant Program, and the amount contributed by the City in the amount of \$255,827 is funded from the Capital Improvement Fund.

Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the City determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the City of Linden may lawfully make as a general improvement.

Section 4. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.

Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.
