The City of Linden is requesting proposals from qualified individuals and firms to provide appraisal services of a specialized nature to the City. Proposals will be evaluated in accordance with the criteria set forth in this RFQ. One or more individuals/firms may be selected to provide services.

PERIOD OF CONTRACT

January 1, 2021 through December 31, 2021

CONTRACT FORM

The successful proposer shall be required to execute the City's form contract, which includes the indemnification, insurance, termination and licensing provisions.

DETAILED REQUIREMENTS OF THE REQUEST FOR PROPOSALS FOR APPRAISAL SERVICES

1. <u>CITY OF LINDEN FACTS AND FIGURES</u> – The City of Linden is a municipal

governmental entity. The City was incorporated in 1925. The legislative authority and responsibilities of the City of Linden is vested in the elected eleven-member Council. The Governing Body sets policy, adopts the operating and capital budgets for the City, enacts ordinances and sets the direction of how the City of Linden will provide government services. The Mayor is the County's chief executive officer and carries out the policies adopted by the Council.

The City's population is approximately 40,499 and it consists of approximately 11 square miles of area. The City employs approximately 606 people in about 25 departments and agencies. It owns administration buildings, courthouse buildings, and parks and recreation facilities.

The City's operating budget is approximately \$110,451,334.69. It provides significant and diverse

services to its residents, including those in the senior, disabled, veterans and other communities.

2. **NATURE/ SCOPE OF SERVICES** – The City of Linden is requesting proposals for appraisal services. The appraiser will be responsible for, but not limited to, such tasks as fair market value analyses of various City-owned properties as well as properties the City is interested in acquiring, including residential land, industrial, commercial, single and multi-family dwellings, and historic and special purpose properties. The successful proposer will also be called upon to perform subdivision analyses for large parcels of vacant land. Findings are to be presented in full narrative reports. In addition, value estimates must be based upon the dictates of the property in question and the reports must be prepared in accordance with the standards of the Appraisal Institute and signed by a State Certified Appraiser with an MAI designation. Said reports must also conform to the guidelines of all agencies having jurisdiction over the Real Estate Appraisal profession. The appraiser will also be responsible for preparing trial litigation filed against the City of Linden. They will also be responsible for the preparation of preliminary reports to help assist the Tax Assessor in settlement negotiations. The appraiser will be responsible for reviewing appraisal prepared by other companies for a variety of reasons not limited to litigations, as well as the principal valuation analysis including, but not limited to, Highest and Best Use Analysis, Market/Sales Analysis, and Replacement Cost/Depreciation Analysis. The appraiser will also be responsible for reviewing appraisals prepared by other appraisal companies as well as the principal valuation analyses including, but not limited to, Highest & Best Use Analysis, Market/Sales Analysis, and Replacement Cost Analysis. The appraiser will also be responsible for preparing reports for tax appeals filed against the city and assisting the Tax Assessor in settlement conference.

The City is requesting proposals for appraisers. Appraisers will, on an "as needed" basis be assigned to projects.

3. <u>STANDARD REQUIREMENTS OF TECHNICAL PROPOSAL</u> - Proposers should submit a technical proposal which contains the following:

- **A.** The name of the proposer, the principal place of business and, if different, the place where the services will be provided.
- **B.** Proposer must have a minimum of fifteen (15) years of experience in appraisal services and a minimum of ten (10) years servicing the City of Linden or other governmental entities.
- **C.** The education, qualifications, experience, and training of all persons who would be assigned to provide services along with their names and titles; Proposer MUST be State Certified and have an MAI designation.
- **D.** A listing of all other engagements where services of the types being proposed were provided in the past five (5) years. The City may obtain references from any of the parties listed.

- **E.** A description of all other areas of appraisal services of the proposer, with emphasis on a description of those services of interest to a City government client.

- **B.** Select only portions of a particular proposer's proposal for further consideration; (However, proposers may specify portions of the proposal that they consider "bundled".)
- **C.** Award a contract for the requested services at any time during the calendar year after all RFQ's have been reviewed and a list of qualified appraisers selected by the City. Every proposal should be valid through this time period.
- **D.** The City shall not be obligated to explain the results of the evaluation process to any proposer.

E. The City may require proposers to demonstrate any services described in their proposal prior to award.

7. <u>**PROPOSAL LIMITATIONS</u>** - This RFQ is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on the City by issuance of this RFQ. The City reserves the right at the City's sole discretion to refuse any proposal submitted.</u>

8. <u>USE OF INFORMATION</u> - Any specifications, drawings, sketches, models, samples, data, computer programs, documentation, technical or business information and the like ("Information") furnished or disclosed by the City to the proposer in connection with this RFQ shall remain the property of the City. When in tangible form, all copies of such information shall be returned to the City upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the City or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFQ, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

9. <u>GENERAL TERMS AND CONDITIONS</u> –

- **A.** The City reserves the right to reject any or all proposals, if necessary, or to waive any informalities in the proposals, and, unless otherwise specified by the proposer, to accept any item, items or services in the proposals should it be deemed in the best interest of the City to do so.
