### **PURPOSE OF REQUEST**

The City of Linden is requesting proposals from qualified individuals and firms (“contractor(s)” or “proposer(s)”) to provide Special Counsel Services of a specialized nature to the City, as determined and assigned by the City Attorney. Special Counsel services include but is not limited to services for Aviation matters, Municipal Port Authority matters, environmental matters, and labor counsel. Proposals will be evaluated in accordance with the criteria set forth in this RFQ. One or more individuals/firms may be selected to provide services.

### **PERIOD OF CONTRACT**

January 1, 2021 through December 31, 2021

### **CONTRACT FORM**

The successful proposer shall be required to execute the City’s form contract, which includes the indemnification, insurance, termination and licensing provisions.

It is also agreed and understood that the acceptance of the final payment by Contractor shall be considered a release in full of all claims against the City arising out of, or by reason of, the work done and materials furnished under this Contract.

## **DETAILED REQUIREMENTS OF THE REQUEST FOR QUALIFICATIONS FOR SPECIAL COUNSEL SERVICES**

1. **City of Linden FACTS AND FIGURES** – The City of Linden is a municipal governmental entity. The City was incorporated in 1925 and operates under N.J.S.A 40:61A-1 et seq. The legislative authority and responsibilities of the City of Linden is vested in the elected eleven-member Council. The Governing Body sets policy, adopts the operating and capital budgets for the City, enacts ordinances and sets the direction of how the City of Linden will provide government services. The

Mayor is the City's chief executive officer and carries out the policies adopted by the Council.

The City's population is in excess of 40,499 and it consists of approximately 11 square miles of area. The City employs approximately 606 full time employees in 25 departments. It owns City Hall, administrative buildings, and parks and recreation facilities. The City's operating budget is over \$110,451,334.69. It provides significant and diverse services to its residents, including those in the senior, disabled, veterans and other communities.

NATURE/ SCOPE OF SERVICES – The City of Linden is requesting proposals for Special Counsel Services, including but not limited to Aviation matters, Municipal Port Authority matters, environmental matters, and labor counsel

The City of Linden is frequently requiring the services of Special Counsel for various legal matters and issues that may from time to time arise. Counsel will have a close working relationship with the Law Department.

The City of Linden is requesting proposals for Special Counsel. Counsel will, on an "as needed basis", be assigned and required to provide representation in such matters as the City may require, including all aspects of litigation, negotiations, research and transactional work.

Counsel may be called upon to attend meetings.

Counsel may also be called upon to provide other types of legal services of a specialized nature.

3. **STANDARD REQUIREMENTS OF TECHNICAL PROPOSAL** - Proposers should submit a technical proposal which contains the following:

B. Proposer must have a minimum of ten (10) years of experience in litigation/defense, and municipal work and a minimum of five (5) years servicing the City of Linden or other governmental entities.

C. The education, qualifications, experience, and training of all persons who would be assigned to provide services along with their names and titles;

D. A listing of all other engagements where services of the types being proposed were provided in the past. This should include other City governments and other levels of government.

Contact information for the recipients of the similar services must be provided. The City may obtain references from any of the parties listed;

E. A description of all other areas of litigation/defense work of the proposer, with emphasis on a description of those services of interest to a City government client;

F. Please provide a description of any particular area(s) of expertise you or your firm may possess that have not been included in the response provided above.

G. A statement that neither the firm nor any individuals assigned to this engagement are disbarred, suspended, or otherwise prohibited from professional practice by any federal, state, or local agency;

H. An Affirmative Action Statement (copy of form attached);

I. A completed Non-Collusion Affidavit (copy of form attached);

J. A completed Owner Disclosure Statement (copy of form attached);

K. A statement that the proposer will comply with the General Terms and Conditions required by the City and enter into the City's standard Professional Services Contract;

L. A copy of the proposer's Business Registration Statement.

M. A completed Partnership Disclosure Statement.

**4. SPECIALIZED REQUIREMENTS OF TECHNICAL PROPOSAL –**

A. Proposer must demonstrate extensive trial experience in Federal and State Courts and administrative agencies.

B. Proposer must indicate which category of Special Counsel Services they are submitting for.

**5. COST PROPOSAL –** Policies and General Legislation the following fee schedule was, the City of Linden shall pay hourly rate of \$125 - \$175 hourly for such services, depending upon the nature of the case, to be determined by the Law Department. By submission of a proposal, proposer acknowledges and agrees to adhere to the fee schedule set forth above.

**6. PROPOSAL EVALUATION –** The City will select the most advantageous proposals based

on all of the evaluation factors set forth at the end of this RFQ. The City will make the award(s) that is in the best interest of the City.

Each proposal must satisfy the objectives and requirements detailed in this RFQ. The successful proposer shall be determined by an evaluation of the total content of the proposal submitted. The City reserves the right to:

- a. Not select any of the proposals;
- b. Select only portions of a particular proposer's proposal for further consideration; (However, proposers may specify portions of the proposal that they consider "bundled".)
- c. Award a contract for the requested services at any time within the calendar year after review of the Qualifications and approval of same by the City; Every proposal should be valid through this time period.

The City shall not be obligated to explain the results of the evaluation process to any proposer.

7. **PROPOSAL LIMITATIONS** - This RFQ is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on the City by issuance of this RFQ. The County reserves the right at the City's sole discretion to refuse any proposal submitted.

8. **USE OF INFORMATION** - Any specifications, drawings, sketches, models, samples, data, computer programs, documentation, technical or business information and the like ("Information") furnished or disclosed by the City to the proposer in connection with this RFQ shall remain the property of the City. When in tangible form, all copies of such information shall be returned to the City upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the City or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFQ, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

9. **GENERAL TERMS AND CONDITIONS** –

A. The City reserves the right to reject any or all proposals, if necessary, or to waive any informalities in the proposals, and, unless otherwise specified by the proposer, to accept any item, items or services in the proposals should it be deemed in the best interest of the City to do so.

**B.** In case of failure by the successful proposer, the City of Linden may procure the articles or services from other sources, deduct the cost of the replacement from money due to the proposer under the contract and hold the proposer responsible for any excess cost occasioned thereby.

**C.** The proposer shall maintain sufficient insurance to protect against all claims under Workmen's Compensation, General, Professional and Automobile Liability.

**D.** Each proposal must be signed by the person authorized to do so.

**E.** The contract shall be in effect through December 31, 2021 unless otherwise stated.

**F.** Proposals may be hand delivered or mailed consistent with the provisions of the legal notice to proposers. In the case of mailed proposals, the City assumes no responsibility for proposals received after the designated date and time and will return late proposals unopened. Proposals will not be accepted by facsimile or e-mail.

**G.** In accordance with Affirmative Action Law, P.L. 1975, c.127 (N.J.A.C. 17:27) with implementation of July 10, 1978, successful proposers must agree to submit individual employer certifications and numbers or complete Affirmative Action employee information report (form AA-302). Also, during the performance of this contract, the contractor agrees as follows: (a) The contractor or subcontractor where applicable, will not discriminate against any employee because of age, race, creed, color, national origin, ancestry, marital status or affectional or sexual orientation. The contractor will take affirmative action to ensure that such applicants are recruited and employed and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, sex or handicap. Such action shall include, but not be limited to the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and section for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notice to be provided by the Public Agency Compliance Officer setting forth provisions of this non-discrimination clause: (b) the contractor or subcontractor, where applicable, will in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, sex or handicap; (c) the contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer advising the labor union or worker's representative of the contractor's

commitments under this act and shall post copies of the notice; (d) the contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the treasurer pursuant to the P.L. 1975, c.127, as amended and supplemented from time to time.

**H.** By submission of the proposal, the proposer certifies that the service to be furnished will not infringe upon any valid patent, trademark or copyright and the successful proposer shall, at its expense, defend any and all actions or suits charging such infringement, and will save the City harmless in any case of any such infringement.

**I.** No proposer shall influence, or attempt to influence, or cause to be influenced, any City officer or employee to use his/her official capacity in any manner which might tend to impair the objectivity or independence of judgment of said officer or employee.

**J.** No proposer shall cause or influence, or attempt to cause or influence, any City officer or employee to use his/her official capacity to secure unwarranted privileges or advantages for the proposer or any other person.

**K.** Should any difference arise between the contracting parties as to the meaning or intent of these instructions or specifications, the City Counsel's decision shall be final and conclusive.

**L.** The City of Linden shall not be responsible for any expenditure of monies or other expenses incurred by the proposer in making its proposal.
