You may be eligible for a cash benefit of \$2,000 per eligible person up to \$4,000 per household.

- If you were excluded from COVID federal relief
- You are over 18 and live in New Jersey
- And your annual household income is less than \$55,000

You will need to show a few documents to demonstrate you are eligible. You can submit your documents online by uploading a picture or a PDF directly from your smartphone or computer on our website.

There are many ways you can demonstrate you are eligible.

**1. You were excluded from Federal COVID relief** (this only applies to the applicant).

- Complete 2020 Tax Returns or
- Bank Statements from April and May 2020, December 2020, January 2021, and April and May 2021.

If you do not have these documents, you should still apply for the Fund. You are required to submit a signed statement of exclusion from federal and unemployment pandemic assistance on the application.
