- No-shows or late arrivals without a phone call to 908-347-3298 before 10:45am the day of the event may result in spaces/tables being released and reassigned to another participant that day without any notice whatsoever, and may prevent participation at future events.
- Exhibitor table set up is allowed ONLY between 10:00am and 10:45 am, and break down is allowed ONLY between 2:00pm and 3:00pm.
- All items belonging to the participant must be removed by the participant by no later than 3:00pm the date of the event, with the understanding that any such items or belongings left behind by the participant become the property of the City of Linden and may be discarded by the City of Linden without any notice to the participant.
- Only one table and two chairs will be provided to each participant who reserves an exhibitor table. Each participant may bring additional folding chairs of their own if needed.
- Tables are strictly first-come, first-served. Tables will not be pre-assigned, reserved, or held in any way.
- No electrical power sources will be provided to the any participant, and no extension cords will be allowed. Participants are allowed to bring their own portable power source (batteries, portable power banks, etc.).
- No water supply lines will be provided to any participant. Any equipment that requires a supply of water to operate are not allowed at the event.
- Any participant offering any food or samples of food (including beverages), will notify the Linden Health Department and obtain any temporary retail food event licenses and/or inspections that may be required.
- The participant agrees that they, their employees, agents, and representatives are voluntarily participating in this event. The participant hereby releases, waives, discharges, covenants not to sue, and holds harmless the City of Linden, it's employees, agents, and representatives (hereinafter referred to as Releasees) from any and all liability, claims, demands, action, judgements, costs, expenses, court costs, attorney fees, and causes of action whatsoever arising out of or related to any loss, damage, illness, or injury, including death, that may be sustained by the participant, their employees, agents, representatives, or to any property belonging to the same, as a result of participating in this event, and voluntarily assume full responsibility for any risks of loss, property damage, or personal illness or injury, including death, that may be sustained by the participant as a result of participating in the event, whether caused by the sole, contributory, or gross negligence of the Releasees or otherwise.

- Any participant exhibiting any symptoms of any communicable illness on the day of the event will be required to leave the event immediately.
